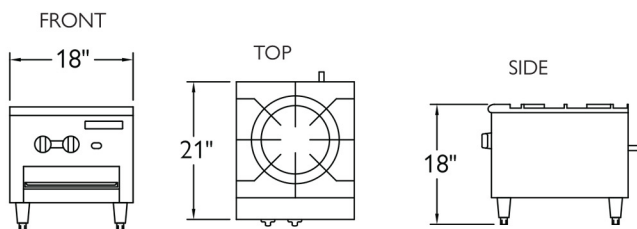
## 3-RING DUAL CONTROL BURNER



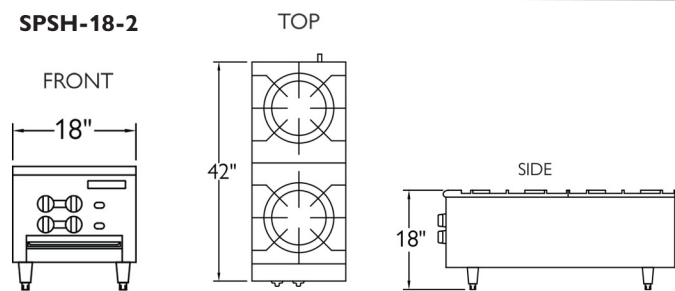

### COMBUSTIBLE WALL CLEARANCES:
